

RESOLUTION 2014 – 03

A Resolution approving the vacation and discontinuance of North Sherburn Place located in part of the Northwest 1/4 of the Northeast 1/4 of Section 9, Township 7 North, Range 22 East, Village of Shorewood, Milwaukee County, Wisconsin.

WHEREAS, on the 21st day of January 2014, the Village of Shorewood entered into a development agreement with Harbor Retirement Associates for the development of parcels located at 1111 E. Capitol Drive (275-8993-000) and 3907-09 N. Sherburn Place (275-8992-002), bordered by E. Capitol Drive, N. Sherburn Place and the Milwaukee River.

WHEREAS, the approved plan for the development of a senior assisted and memory care facility at 3907-09 N. Sherburn Place and 1111 E. Capitol Drive includes the discontinuance of North Sherburn Place.

WHEREAS, the public interest requires that said North Sherburn Place be vacated and discontinued, in accordance with the provisions of Section 66.1003(4) of the Wisconsin Statutes.

WHEREAS, on the 17th day of December 2013, the Village Plan Commission recommended to the Village Board to vacate the public right of way North Sherburn Place.

WHEREAS, a new public road will be constructed within the River District as part of the project, giving accessibility to parcels served by North Sherburn Place.

WHEREAS, the Village has investigated prior property ownership of the section and the adjacent parcels to determine the proper reversion of Title per section 66.1005 of the Wisconsin Statutes.

WHEREAS, the development agreement includes that the Title to the Bluff Parcel shall be conveyed to the Village of Shorewood in keeping with the Village's 2009 River Riparian Restoration and Trail Plan to improve and expand on its green spaces.

NOW THEREFORE, BE IT RESOLVED by the Village Board of the Village of Shorewood, Milwaukee County, Wisconsin that a public hearing was held on the 3rd day of February, 2014 at 7:30 P.M. at the Shorewood Village Hall, 3930 N. Murray Avenue, Shorewood Wisconsin, to consider the proposed vacation and discontinuance of North Sherburn Place, consistent with its previous Resolution 2013- 25 dated December 16, 2013.

BE IT FURTHER RESOLVED that the Village Clerk has published a Class 3 Notice of said public hearing under the provisions of Chapter 985 of the Wisconsin Statutes before the date of said hearing.

BE IT FURTHER RESOLVED that the Village Clerk has duly served a copy of the notice to all of the owners of the property abutting North Sherburn Place to be vacated and discontinued at least forty (40) days before said date of hearing.

BE IT FURTHER RESOLVED by the Village Board of the Village of Shorewood, that the public interest requires the vacation and discontinuance of all rights of the Village of Shorewood of North Sherburn Place, located south of Capitol Drive, east of the Milwaukee River and west of the Milwaukee County Oak Leaf Trail, within the Village of Shorewood, Milwaukee County, Wisconsin, as shown in the attached Exhibit A and as described as follows:

Being all that part of the vacated North Sherburn Place right of way located in part of the Northwest Quarter of the Northeast Quarter of Section 9, Township 7 North, Range 22 East, Village of Shorewood, Milwaukee County, Wisconsin, bounded and described as follows:

Commencing at the northwest corner of the Northeast $\frac{1}{4}$ of said Section 9; thence North $88^{\circ}51'15''$ East along the north line of said Northeast $\frac{1}{4}$, 375.96 feet to the vacated east right of way line of North Sherburn Place as extended northerly; thence South $35^{\circ}10'45''$ East along said east line, 104.98 feet to the northeast corner of said vacated North Sherburn Place and the point of beginning (said point being 87.00 feet south of the north line of said Northeast $\frac{1}{4}$ as measured perpendicular);

Thence South $35^{\circ}10'45''$ East along the vacated east right of way line of North Sherburn Place, 233.38 feet to the southeast corner of said vacated North Sherburn Place; thence South $54^{\circ}51'15''$ West along the vacated south right of way line of North Sherburn Place, 35.00 feet; thence North $35^{\circ}10'45''$ West, 257.00 feet to the vacated north right of way line of North Sherburn Place; thence North $88^{\circ}51'15''$ East along said vacated north right of way line, 42.23 feet to the point of beginning.

Containing in all 8,582 square feet (0.1970 acres) of land, more or less.

BE IT FURTHER RESOLVED that the proof having been filed with the Village Board, that all notices have been published, served and filed as required by Section 66.1003 of the Wisconsin Statutes, the hearing on the passage of this resolution having been duly held in accordance with the provisions of Section 66.1003, and the Village Plan Commission having recommended the vacation and discontinuance, the described section for the North Sherburn Place right of way, be and the same is hereby vacated and discontinued pursuant to the authority vested in the Village Board of the Village of Shorewood by Sec. 66.1003 of the Wisconsin Statutes.


BE IT FURTHER RESOLVED that pursuant to the Village's investigation into the property ownership of the section and abutting properties, Title may revert to abutting

properties and that there be attached to this resolution and made a part hereof as if fully set forth herein a map (attached as Exhibit B) showing the land affected by said vacation and sections shall revert to the properties in accordance with the provisions of Section 66.1005 of Wisconsin Statutes.

BE IT FURTHER RESOLVED that said vacation and discontinuance shall not terminate the easements and rights incidental thereto in any underground or overground structures, improvements or services as may be existing and as may be shown in Exhibit C and all rights of entrance, maintenance, construction of the same will continue as if the right of way had not been vacated.


BE IT FURTHER RESOLVED that this resolution shall be final and take effect from and after its passage and recording by the Village of Shorewood pursuant to law.

LEGAL DESCRIPTION

Commencing at the northwest corner of the Northeast 1/4 of said Section 9; thence North 88°51'15" East along the north line of said Northeast 1/4, 315.06 feet to the west right of way line of North Sherburn Place as extended northerly; thence South 35°10'45" East along said west line, 104.98 feet to the northwest corner of said North Sherburn Place and the point of beginning (said point being 87.00 feet south of the north line of said Northeast 1/4 as measured perpendicular);

Thence North 88°51'15" East along north right of way of line of said North Sherburn Place (being parallel with and 87.00 feet south of the north line of said Northeast 1/4), 60.33 feet to the northeast corner of said North Sherburn Place; thence South 35°10'45" East along the east right of way line of North Sherburn Place, 233.38 feet to the southeast corner of said North Sherburn Place; thence South 54°51'15" West along the south right of way line of North Sherburn Place, 50.00 feet to the southwest corner of said North Sherburn Place; thence North 35°10'45" West along the west line of said North Sherburn Place, 267.12 feet to to the point of beginning.

Containing in all 12,513 square feet (0.2872 acres) of land, more or less.







