RESOLUTION 2011 - 26

A Resolution Dividing and Designating
Election Wards in the Village of Shorewood

WHEREAS, the Milwaukee County Board adopted a plan for the redistricting of the County Board based on the official 2010 census; and

WHEREAS, the County redistricting plan necessitates the adjustment of wards to accommodate the county supervisory district plan; and

WHEREAS, State law mandates the creation of election wards within the Village which shall contain a range of population from 600 to 2,100; and

WHEREAS, Where as the Village Board of the Village of Shorewood must comply within 60 days after receipt of the supervisory plan,

NOW THEREFORE, at a regular meeting of the Village Board of the Village of Shorewood, held on the 8th day of August, 2011, a quorum being present and a majority of the Board voting therefore, said Board does resolve as follows:

WARD 1 shall run from and include the area within and between the south side of North Capitol Drive from North Morris Boulevard to the western Village boundary; the west side of North Morris Boulevard from North Capitol Drive to East Menlo Boulevard; the south side of E Menlo Boulevard from North Morris Boulevard to North Oakland Avenue; and the west side of North Oakland Avenue from East Menlo Boulevard to the southern Village boundary. This is comprised of Census Tract 080400, Block 3001. The polling place shall be located in the lower level of the Shorewood Library/Village Center, 3920 N Murray Avenue.

WARD 2 shall run from and include the area within and between the south side of East Capitol Drive from North Morris Boulevard to North Murray Avenue; the west side of North Murray Avenue from East Capitol Drive to East Menlo Boulevard; the north side of East Menlo Boulevard from North Murray Avenue to North Morris Boulevard; and the east side of North Morris Boulevard from East Menlo Boulevard to East Capitol Drive. This is comprised of Census Tract 080400, Blocks 2000, 2001, 2002, 2003, 2004, 3000, 3003, and 3004. The polling place shall be located in the lower level of the Shorewood Library/Village Center, 3920 N Murray Avenue.

WARD 3 shall run from and include the area within and between the east side of North Oakland Avenue from East Menlo Boulevard to the southern Village boundary; the south side of East Menlo Boulevard from North Oakland Avenue to North Murray Avenue; the west side of North Murray Avenue from East Menlo Boulevard to East Capitol Drive; the south side of East Capitol Drive from North Murray Avenue to North Prospect Avenue; the west side of North Prospect Avenue from East Capitol Drive to the southern village boundary; the north side of East Edgewood Avenue from North Prospect Avenue to North Oakland Avenue. This is comprised of Census Tract 080300, Blocks 1000, 1001, 1002, 1003,

1004, 1005, 1006, 1007, 2005, 2006, and Census Tract 080400, Blocks 4003, 4004, 4005, 4006, 4009, 4010, 5004, 5005, and 5012. The polling place shall be located in the lower level of the Shorewood Library/Village Center, 3920 N Murray Avenue.

WARD 4 shall run from and include the area within and between the east side of North Prospect Avenue from East Capitol Drive to the southern Village boundary; the south side of East Capitol Drive from North Prospect Avenue to North Lake Drive; the west side of North Lake Drive from East Capitol Drive to the southern Village boundary. This is comprised of Census Tract 080300 Blocks 3006, 3007, 3008, 4000, 4001, 4002, 4007, 4008, 5000, 5001, 5003, 5006, 5007, 5008, 5009, 5010, 5011, 5013. The polling place shall be located in the lower level of the Shorewood Library/Village Center, 3920 N Murray Avenue.

WARD 5 shall run from and include the area within and between the east side of North Lake Drive from the southern Village boundary to the northern Village boundary; the north side of East Capitol Drive from North Maryland Avenue to North Lake Drive; the east side of North Maryland Avenue from East Capitol Drive to East Olive Street; the south side of East Olive Street from North Maryland Avenue to North Lake Drive; the west side of North Lake Drive from East Capitol Drive to East Olive Street. This is comprised of Census Tract 080300, Blocks 1006, 1007, 1008, 1009, 1010, 1011, 2002, 2012, 3000, 3001, 3002, 3003, 3004, 3005, 3010. The polling place shall be located in the Shorewood High School, 1701 East Capitol Drive.

WARD 6 shall run from and include the area within and between the west side of North Lake Drive from the northern Village boundary to East Olive Street; the north side of East Olive Street from North Maryland Avenue to North Lake Drive; the east side of North Maryland Avenue from East Olive Street to East Lake Bluff Boulevard; the north side of East Lake Bluff Boulevard from North Maryland Avenue to North Frederick Avenue; the east side of North Frederick Avenue from East Lake Bluff Boulevard to the northern Village boundary. This is comprised of Census Tract 080300, Blocks 1000, 1001, 1002, 1003, 1004, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011. The polling place shall be located in the Shorewood High School, 1701 East Capitol Drive.

WARD 7 shall run from and include the area within and between the north side of East Capitol Drive from North Maryland Avenue to North Larkin Street; the west side of North Maryland Avenue from East Capitol Drive to East Olive Street; the south side of East Olive Street from North Maryland Avenue to North Larkin Street; the east side of North Larkin Street from East Olive Street to East Capitol Drive. This is comprised of Census Tract 080200, Blocks 2007, 2008, 2009, 2010, 3000, 001, 3002, 3003, 3006, 3007, 3008, 3009, 3010, 3011, 3012. The polling place shall be located in the Shorewood High School, 1701 East Capitol Drive.

WARD 8 shall run from and include the area within and between the west side of North Frederick Avenue from East Lake Bluff Boulevard to the northern Village boundary; the south side of East Lake Bluff Boulevard from North Frederick Avenue to North Maryland Avenue; the west side of North Maryland Avenue from East Lake Bluff Boulevard to East Olive Street; the north side of East Olive Street from North Maryland Avenue to North Oakland Avenue; the east side of North Oakland Avenue from East Olive Street to the northern Village boundary. This is comprised of Census Tract 080200, Blocks 1000, 1001, 1002, 1013, 1014, 1015, 2000, 2001, 2005, 2006, 2022. The polling place shall be located in the Shorewood High School, 1701 East Capitol Drive.

WARD 9 shall run from and include the area within and between the north side of East Capitol Drive from North Larkin Street to North Woodburn Street; the east side of North Woodburn Street from East Capitol Drive to East Lake Bluff Boulevard; the south side of East Lake Bluff Boulevard from North Woodburn Street to North Oakland Avenue; the west side of North Oakland Avenue from East Lake Bluff Boulevard to East Olive Street; the north side of East Olive Street from North Oakland Avenue to North Larkin Street; the west side of North Larkin Street from East Olive Street to East Capitol Drive. This is comprised of Census Tract 080100 blocks 1007, 1008, 2006, 2007, 2008 and Census Tract 080200 Blocks 2002, 2003, 2004, 2011, 2012, 3004, 3005. The polling place shall be located in the Shorewood Intermediate School, 3830 North Morris Boulevard.

WARD 10 shall run from and include the area within and between the north side of East Capitol Drive from North Woodburn Street to the western Village boundary; the west side of North Woodburn Street from East Capitol Drive to East Lake Bluff Boulevard; the south side of East Lake Bluff Boulevard from North Woodburn Street to North Ardmore Avenue; the west side of North Ardmore Avenue from East Lake Bluff Boulevard to East Congress Street; the south side of East Congress Street from North Ardmore Avenue to the western Village boundary. This is comprised of Census Tract 080100 Blocks 1006, 1009, 2000, 2001, 2002, 2003, 2004, 2005, 2009, 3024, 3025, 3026, 3032. The polling place shall be located in the Shorewood Intermediate School, 3830 North Morris Boulevard. The polling place shall be located in the Shorewood Intermediate School, 3830 North Morris Boulevard.

WARD 11 shall run from and include the area within and between the west side of North Oakland Avenue from North Lake Bluff Boulevard to the northern Village boundary; the north side of East Lake Bluff Boulevard from North Oakland Avenue to North Woodburn Street; the east side of North Woodburn Street from East Lake Bluff Boulevard to the northern Village boundary. This is comprised of Census Tract 080100 blocks 1000, 1003, 1004 and Census Tract 080200, blocks 1003, 1004, 1005, 1006, 1007, 1008, 1009, 1010, 1011, 1012, 2023, 2024. The polling place shall be located in the Shorewood Intermediate School, 3830 North Morris Boulevard.

WARD 12 shall run from and include the area within and between the west side of North Woodburn Street from East Lake Bluff Boulevard to the northern Village boundary; the north side of East Lake Bluff Boulevard from North Woodburn Street to North Ardmore Avenue; the east side of North Ardmore Avenue from East Lake Bluff Boulevard to East Congress Street; the north side of East Congress Street from North Ardmore Avenue to the western Village boundary. This is comprised of Census Tract 080100, Blocks 1001, 1002, 1005, 3005, 3006, 3007, 3010, 3011, 3012, 3013, 3014, 3015, 3016, 3017, 3018, 3019, 3020, 3021, 3022, 3023, 3027, 3028, 3029, 3033. The polling place shall be located in the Shorewood Intermediate School, 3830 North Morris Boulevard.



BE IT FURTHER RESOLVED, the Wards 1, 2, 3 and 4; Wards 5, 6, 7 and 8; and Wards 9, 10, 11 and 12 shall use common voting machines in their respective polling places.

BE IT FURTHER RESOLVED, that the provisions of this resolution shall supersede the provisions of all prior resolutions related hereto and conflicting herewith.


