Vision Exam (one time per year) • Complete 'Routine Vision Exam' Affidavit	25		
Flu Shot (or any other medically necessary shot approved by Wellness Committee) • Complete 'Flu Shot' Affidavit	25		
Gym Membership Visit a Gym a minimum of 4 times/month for at least 6 months • Provide proof of attendance from Gym	50		
Track Steps Complete at least 1,000,000 steps • Provide print out of total step count From device	50		
Participate in Community Service related to Wellness 25 points per event, up to 2 times per year • Examples include: blood donation, volunteer coaching, Big Brother/Sister, etc. • Complete 'Community Service' Affidavit	50

• Blood Glucose - 113 mg/dL or lower	10		
• Blood Pressure - 129/79 or lower	10		
• Total Cholesterol/HDL Ratio - 4.0 or lower	10
