Good morning,

First of all, congratulations to all 13 of you! This past Monday the Village Board appointed you all to the Parks and Public Spaces Committee. Our first meeting will be Tuesday, June 8 at 6:00 p.m. and will be held virtually. Meetings will always be the second Tuesday of the month and will last up to 7:30 p.m. We are asking all new appointees to attend a volunteer committee orientation on Wednesday, June 16 at 6:00 p.m. in the lower level of Village Center.

At the first meeting, because we don't have a chair elected yet, Trustee Kathy Stokebrand who will serve as the committee's Trustee liaison will chair the meeting. An agenda for the meeting will go out the Thursday before the meeting (June 3 for next month) via email. At the first meeting, we will elect a Chair and Vice Chair. We will also need to divide into three subcommittees: Parks, Pedestrian and Bike Safety, and Other Public Spaces. Besides the monthly commitment of attending the Parks and Public Spaces Committee, you will be working with subcommittees between meetings to get work done on different initiatives. To give you a sense of what each subcommittee may be working on in the next 12 months, below is a general list of topics. Please note that this list is subject to change pending on what you all or the Village Board feel should be a priority.

**Parks** – Update the Comprehensive Park Plan, Review process to rent space at parks, Review park and beach rules, Research potential new amenities for the parks

**Pedestrian and Bicycle Safety** – Provide education on ped and bike safety practices, Promote and coordinate activities for Bike Month in May, Review and recommend ped and bike safety improvements throughout the Village, Review access to Oak Leaf Trail and mountain bike trails

**Other Public Spaces** – Implement and oversee dog waste stations, review and recommend appropriate holiday decorations and lights in public spaces, review policy related to signs and communicative structures in the right-of-way

We will be dividing the committee up so that there will be 4 members in each subcommittee (this does not include ex officio members or non-committee volunteers who elect to help out with these efforts). Each subcommittee person will need a lead person to be accountable for the subcommittee to make progress on their items. The Chair will oversee the 3 subcommittees, facilitate meetings, attend other meetings on behalf of the committee, and meet with me once a month to set the agenda. Please consider which subcommittee you'd like to serve on and if you'd like to be chair.

Lastly, it may be helpful for you to read the current Comprehensive Park Plan as well as the Pedestrian and Bicycle Master Plan. # Parks & Public Spaces Committee

## Overview

The Parks and Public Spaces Committee is a committee that initiated in 2021. It is a consolidation of the Parks Commission and the Pedestrian and Bicycle Safety Committee to allow both groups to collaborate on issues and public events. Here is a summary of the purpose and function of the Committee:

- Provide general review and recommendations on the physical improvement, maintenance and use of all Village parks, park facilities, and other Village owned public spaces. Items in the public right-of-way (i.e. street reconstruction or resurfacing, utility improvements, signs, tree planting or removal, lighting, etc.) will only be reviewed by the Committee if it is requested by a Village department or the Village Board.
- Review policies related to events and objects in the public right-of-way and make recommendations, if appropriate, to the Village Board and/or staff.
- Present an updated Comprehensive Outdoor Recreation Plan and Pedestrian and Bicycle Safety Master Plan for the Village Board to consider for approval.
- Collaborate with the Shorewood Recreation Department, School District, Milwaukee County Parks, other Village committees, Village departments, and other community groups on initiatives to improve the Village's parks, park facilities and other public spaces.
- Create educational programs and events that inform community members about the Village's parks, park facilities and other public spaces outlined in the Village Code. Events may also celebrate Shorewood as a bikeable and walkable community.
- Create civic engagement opportunities for community members to provide feedback on park uses, pedestrian and bicycle safety, transportation issues, and other topics related to public spaces.
- Publish annual report outlining initiatives completed, priorities for the upcoming year, and common themes heard from public input. Consult Village departments and community groups for valuable metrics and possible initiatives.
- Perform such other duties and assume such other responsibilities as it may be assigned by the Village Board.
