


That this Ordinance shall take effect and be in force from and after its passage and posting/removal of corresponding regulations.

ORDINANCE NO. 3054

AN ORDINANCE AMENDING PARKING REGULATIONS  
ON N. ESTABROOK PARKWAY SOUTH OF E. CAPITOL DRIVE

WHEREAS, the Village of Shorewood undertook a comprehensive Transportation and Parking Analysis in 2019, which was formally received by the Village Board on February 17, 2020;

WHEREAS, the Transportation and Parking Analysis was guided by a Technical Advisory Group comprised of representative stakeholders who recommended receipt of the Analysis with the overarching goals to improve accessibility, ease communication, standardize regulations and improve enforcement;

WHEREAS, in conjunction with the Analysis' stated goal of consistency, and in relation to parking standards related to street width, this ordinance would further those prior efforts as it relates to eliminating parking on one side of N. Estabrook Pkwy. south of E. Capitol Dr. year-round, since it is less than 30 ft. wide;

WHEREAS, on March 20, 2023, the Public Works Committee unanimously recommended that parking be prohibited on the east side of the street in order to provide the most possible number of parking spaces, avoid conflicts with driveways and increase visibility at the intersection of E. Capitol Dr.;

NOW THEREFORE, at a regular meeting of the Village Board of the Village of Shorewood, Milwaukee County, Wisconsin, held on the 3<sup>rd</sup> day of April, by a favorable vote of the members being present and therefore, said Board does ordain as follows:

**SECTION 1**

Subsection D "Streets" of Section 500-17 "Parking prohibited" of Article VIII "Parking Limits and Regulations" of Chapter 500 "Vehicles and Traffic" shall be amended by adding the following:

**SECTION 2**

Paragraph (3) of Subsection A of Section 500-26 "Winter Parking" of Article VIII "Parking Limits and Regulations" of Chapter 500 "Vehicles and Traffic" shall be amended by removing the following:

N. Estabrook Parkway                      From E. Capitol Drive south thereof
