| Title: | Use of Atwater Park/Beach | |

The Village Board is adopting Policy No. 26 for the purpose of establishing guidelines for the use of Atwater Park/Beach.

It is not lawful for any person or persons to use the beach area of Atwater Park or any of its facilities or improvements or enter upon the premises thereof for any purpose without the written approval of the Village Manager except during the hours established by the Village Board and posted at the top of the bluff entrance. The “beach area” is defined as that area below the top of the bluff of Atwater Park. The hours when the beach area is open to the public, and the fees (if any) to be charged for the use of said area, will be determined by the Village Board.

Permits for Atwater Park

1. It shall be unlawful for any groups, organizations or businesses to use Atwater Park or any of its facilities or improvements or enter upon the premises, unless such groups, organizations or businesses shall have procured a valid permit for such usage from the Village of Shorewood and paid the required fee, which shall be established by the Village Board.
2. Such permit shall be presented upon request to any Village Official and shall be valid only for the period of time for which the same has been issued and be used only by the groups, organizations or businesses therein named.

Qualification for Permits

3. (1) Groups, organizations or businesses may obtain a permit from the Village by paying the fee charged; charges shall be determined by the Village Board.
4. (2) Village civic groups may obtain a group permit from the office of the Village Manager without fee, valid for one day only.
5. D. Permits revocable. All permits issued shall be revocable by the Village Manager or the Chief of Police, or a member of the Police Department in charge in the Chief's absence, for unbecoming conduct and for failure to observe any of the Village ordinances regulating or covering the usage thereof.

Rules and Regulations

6. (1) The Village Board shall prescribe rules and regulations for the operation of Atwater Park. Such rules and regulations shall govern the time when the beach shall be open to the public each year, the hours of beach operation, the charges to the public for the use of facilities, improvements, and grounds, the nature and types of activities which may be undertaken on the premises, and related matters.
7. (2) Such rules and regulations, upon approval by the Village Board, shall have the full force of law, and a violation thereof shall be subject to the penalties hereinafter provided.

Beach Fees

Reviewed and established annually by the Village Board.

Hours of Operation

Per modification by Village Board at its meeting of June 4, 2012:

The "beach area" will be open to the public on a daily basis from 5 A.M. to 9 P.M. The "beach area" is defined as that area below the top of the bluff of Atwater Park.

- A) Lifeguards will be on duty as contracted by the Village Board annually.

Boat Launching Permit
